UNOPS or its representative shall inspect and/or test any or all items of the goods to confirm their conformity to the contract, upon delivery. Such inspection and clearance will not prejudice the right of the consignee to inspect and test the goods on receipt at destination.

If the goods fail to meet the laid down specifications, the supplier shall take immediate steps to remedy the deficiency or replace the defective goods to the satisfaction of the purchaser.
