**Background:**

The ILO has been providing technical assistance to the Ministry of Labour, Employment, and Social Security (MoLESS) of Nepal for the ratification of P29, C81, and C87. The ratification process is progressing positively towards the approval by the council of cabinet in near future. The ILO constituents are working towards ratifying ILO Conventions C155, C187, C190 and C189 in 2025/2026

As part of its technical assistance, the ILO has supported MoLESS in preparing promotional materials, particularly information briefs on P29, C81, and C87, for dissemination among constituents, parliamentarians, and relevant stakeholders. These materials highlight the key provisions of the Conventions and Protocols, their significance, the benefits of ratification, areas for improvement in national legislation and policies, and the role of stakeholders.

Additionally, to facilitate the ratification process, a package of information related to the ILO Conventions (in both English and Nepali) needs to be shared with cabinet ministers and members of parliament. MoLESS has requested ILO Nepal to print and provide these materials in booklet forms.

In this connection, ILO Nepal is preparing to print various documents related to the promotion of ratification of above-mentioned ILO Conventions and is seeking a supplier for printing different documents which is critical in raising awareness amongst the stakeholders. The printed documents will be distributed amongst the ILO constituents.
