The Office of the United Nations High Commissioner for Refugees (UNHCR), established on December 14, 1950 by the United Nations General Assembly¹, requests your price quotation for the following [Short Messaging Services (SMS)] specified in this Request for Quotation (RFQ).

1. REQUIREMENTS

Description: UNHCR Korea needs to contact donors with various communication methods. Currently we use phone calls, emails, post and SMS, donors prefer SMS as the communication method based on donor survey.

Short Messaging Services (SMS) is a text message service using standard communication devices, which allow the exchange of short text message. We want to use this text message service including MO service (Mobile-Originated Service) to communicate with donors via mobile phone.

The Vendor should be able to provide an independent platform for UNHCR to load data and send SMS in Korean. The platform should be easy to operate and the access should be controlled by UNHCR, in other words, the vendor should not have access to the data.

The SMS platform should:

- Allow user to customize sender name
- Include reports that can capture the delivery status and response rate. We should be allowed to generate reports on monthly and daily basis
- Include MO service that can receive and accumulate donor's response and message for us to follow up each donor's response. We will use 2 MO numbers
- Allow merge function in order for us to have personalize message
- Provide schedule send function

The quantities provided in Annex B are estimated volumes, actual usage may vary.

Project duration: service starting from the appointment of the selected service provider until 31 December 2021.


