### **2.- Offer Submission:**

**2.1** The offers for the vehicle must be submitted using the "Offer Submission Form" in the page 4 of this document.

**2.2** The Offer Submission Form" must be completed, signed, and a picture is to be sent via email to the following address: [hqprocurement@icao.int](mailto:hqprocurement@icao.int) with the Subject "Offer for Auction. 12501131"

**2.3** The email with the picture of your offer must be received on or before 11:59P.M. of June 15, 2021; Montreal Time.

**2.4** Once we receive your offer, an acknowledge of receipt will be issued.

**2.5** The offers must be submitted, presenting the amount of your bid in Thailand Baht Currency.

**2.6** ICAO reserves the right of: not accepting any offer; cancel or repeat the auction; reject any or all Bids received in response to the Bid solicitation; enter into negotiations with Purchasers on any or all aspects of their Bids; accept any Bid in whole or in part without negotiations; cancel the Bid solicitation at any time; reissue the Bid solicitation;

**2.7** All sales are final. No purchased Goods may be returned and no requests for reimbursement in whole or in part will be accepted.

**2.8** Offers received after the deadline will be rejected.

### **3.- Sale:**

**3.1** The goods will be offered for sale to the highest bid, providing it's equal or higher than ICAO's reserve price.

**3.2** ICAO will issue an invoice for the vehicle;

**3.3** The Purchaser will be responsible for ALL Costs related to the registration, property transfer and taxes due to the acquisition of the vehicle.

#### **4.- Payment:**

**4.1** After being notified via email, the Highest Bidder must proceed to **effect payment within five business days**. In the case such payment is not made within the aforementioned timeframe, the goods will be offered to the next high bid.

#### **5.- Warranty:**

**5.1** All Goods are sold on an "as-is/where-is" basis. ICAO makes no warranty, expressed or implied, legal, contractual or verbal, as to the quantity, kind, character, quality, weight, size, condition or fitness for any use or purpose with respect to the Goods listed here. Goods are purchased at the Purchaser's own risk and peril.

#### **6.- Pick-Up:**

**6.1** ICAO will arrange NO deliveries; the Bidder shall bear all the costs associated with the removal of the machinery.

**6.2** The goods will be available for Pick-up at ICAO premises to the Buyer once the offered price has been paid in full.

**6.3** The goods **shall be removed from ICAO's premises within 15 business days** after they are available for Pickup.

**6.4** If the Purchaser sends a third party to pick up the item(s) on their behalf, they must send an e-mail to ICAO giving permission to release the item(s). Failure to do so may result in your item(s) not being released.

**6.5** Purchaser must come equipped and prepared with proper equipment to pick up the lot from the building, example: dollies, carts, vehicle and/or trucks, as well as proper amount of help for the move.

**6.6** Purchaser will be liable for any personal injury or damage to ICAO property while removing the lot.

#### **7. Disclaimers and Other T&Cs**

**7.1** The description of the Goods is based on the best information available to ICAO.

**7.2** All Goods sold "as-is/where-is" basis; ICAO makes no warranty, expressed or implied, legal, contractual or verbal, as to the quantity, kind, character, quality, weight, size, condition or fitness for any use or purpose with respect to the Goods listed. Goods are purchased at the Purchaser's own risk and peril;

**7.3** Any mention of a sale item's condition in the sales listing represents the best assessment of the sales representative at the time of listing and is offered for guidance only and is not an enforceable condition of sale.

**7.4** Inspection prior to submitting an offer is the responsibility of the Bidder and may be arranged by appointment only during regular office hours at the location indicated above.

**7.5** When making an Offer to Purchase, the Bidder acknowledges that they have been provided with full opportunity to inspect the Goods and is fully satisfied with respect to the condition of the Goods.

**7.6** Bids cannot be cancelled. Once an Offer to Purchase is made, a Bidder may not withdraw it. However, a Bidder may modify their Offer to Purchase at any time before the closing date indicated on the listing. After the closing date, the Offer to Purchase cannot be changed and is irrevocable;

**7.7** ICAO reserves the right to reject any or all Offers to Purchase, if it believes the Offer to Purchase does not meet one or more of the Terms and Conditions of Sale.

**7.8** It is essential that payment be made and goods removed within the time frame stipulated in this Agreement. Non-compliance of payment or removal will lead to the cancellation of the sale, awarding to the next highest bidder or re-listing of the sale, and the non-compliant buyer may be responsible for liquidated damages.

**7.9** After the closing date for the submission of Offers to Purchase the Goods, ICAO may accept the Offer to Purchase that provides the "best value" where Best Value is defined as: best price; and acceptance of all applicable terms and conditions by bidder; and Any other rated or mandatory criteria that may be specifically applicable.

**7.10** Acceptance of the successful Offer to Purchase will be communicated by e-mail notification to the winning Bidder following the close of the sale.

**7.11** All sales are final. No purchased Goods may be returned and no requests for reimbursement in whole or in part will be accepted.

**7.12** Payment for the Goods must be made following notification that your bid has been accepted and in accordance with the number of payment days indicated above. Payment must be made in full and in accordance with the instructions provided by ICAO.

**7.13** The Invoice will be available to the Purchaser following the payment in full;

**7.14** Failure of Purchaser to remove all the purchased Goods at the specified time in accordance with all applicable terms and conditions will be deemed to be a breach of contractual condition; in which event ICAO may at its sole discretion terminate the contract of sale and retain payment.

**7.15** Removal of the Goods will be allowed only after payment in full;

Removal of the Goods must be done at the location following payment or in accordance with the number of removal days identified on the individual sales listing.

**7.16** Packing, loading and removal of the Goods are the sole responsibility of the Purchaser and at the Purchaser's own expense;

**7.17** In a situation where the removal of the Goods is not possible due to ICAO's actions or negligence, ICAO's liability shall be limited to a refund of the full purchase price of the Goods; Any damage to the Goods sold, as well as any damage to ICAO's property by the Purchaser, during the removal of the Goods, shall be the sole responsibility of the Purchaser.

**7.18** The Purchaser must have the proper material handling and safety equipment and transportation to pick up their items. If, in the opinion of ICAO, the equipment or methods used to remove the items are deemed unsafe, the custodian may refuse the pickup and withdraw any assistance.
