4	The supplier must guarantee 24/7 technical customer support in Ukraine during the warranty period required in the Section II - Schedule of Requirements, to be provided by the authorized service provider. A list and contact details of the authorized service providers in Ukraine for the technical customer support, which will be engaged by the supplier within the warranty period and available after its expiration, must be submitted.
5.	Bidder must be an authorized representative or reseller for the offered equipment. A copy of the official authorization from the manufacturer or its official or authorized representative is required (permanent, or issued for this tender only).

E. Inspections and tests

The following inspections and tests shall be performed:

UNOPS or its representative may inspect and/or test any or all items of the goods to confirm their conformity to the contract, prior to dispatch from the supplier's premises. Such inspection and clearance will not prejudice the right of the consignee to inspect and test the goods on receipt at destination.

If the goods fail to meet the laid down specifications, the supplier shall take immediate steps to remedy the deficiency or replace the defective goods to the satisfaction of the purchaser.
