REQUEST FOR INFORMATION (RFI) – DXB22.0499.RFI.HRD

Generators for Ukraine Mills

Closing on 5th December 2022 at 23:00 hrs (Dubai Time)

A. Background

1. The United Nations World Food Programme hereinafter referred to as the “WFP”, with its Headquarters located in Via C.G. Viola, 68/70, 00148 Rome, Italy is the leading humanitarian organization saving lives and changing lives, delivering food assistance in emergencies and working with communities to improve nutrition and build resilience by assisting almost 100 million people in around 83 countries each year. About 17,000 people work for the organization, most of them in remote areas, directly serving the hungry poor.
2. The WFP office in Dubai seeks to satisfy the following procurement needs: for generators to keep the milling plants going through all the power cuts for Ukraine.
3. WFP invites suppliers operating on the relevant market to provide information about the generators/power supply plant they offer.

B. The purpose of this RFI

4. The purpose of this RFI is to gain a more detailed understanding of the supply market and existing solutions both to identify suppliers with experience in a particular area and to gain knowledge about generators/power plant suppliers, the fuel consumption and the estimated cost of these generators.
5. After the deadline for submission of responses has passed, WFP will review responses received and will notify eligible participants of the outcomes of this initiative.
