**Objectives and Scope**

UNESCO initiates the implementation of a project titled 'E-governance in the Education Sector in Ukraine' aimed at supporting education in emergency in Ukraine through the accelerated delivery of targeted interventions. Project is supported by the Global Partnership for Education under the endorsement of the Ministry of Education and Science of Ukraine and the Ministry for Digital Transformation of Ukraine.
