**D. Sustainability criteria - to be evaluated as part of technical evaluation based on Pass/Fail**

**Sustainable criteria** - Bidders should provide Gender and social inclusion mainstreaming plans of the organisation which explains the practical plan (or demonstrate experience) for implementing gender mainstreaming (and/or social inclusion) activities during the execution of the contract, from planning to closure.

**E. Physical Product Inspections**

UNOPS or its representative shall physically inspect all items of the goods to confirm their conformity to the technical specifications before any payment is made. Such inspection and clearance will not prejudice the right of the consignee to inspect and test the goods on receipt at destination.

If the goods fail to meet the laid down specifications, the supplier shall take immediate steps to remedy the deficiency or replace the defective goods to the satisfaction of the purchaser.
