Item 1. Dignity kits for women – 4000 kits				
1.1	Soap bar	<p>Toilet soap bar, individually wrapped, skin friendly, antibacterial, suitable for both baby and adults, preferably non-scented, firm and smooth in texture, should generally contain, fatty acids, surfactants, preservatives and moisture. 2.1.	Coloring pencil pack	Pencil, coloring, metal, paper or plastic box containing 12 assorted colors. Coloring pencils in quality wood casing, without eraser, sharpened, hexagonal shape, length minimum 170mm, maximum 180mm. Set of 12 assorted colors, soft leads (core approximately 3mm.) for easy writing for school children, packed in a flat metal box with tight closure. A plastic pencil sharpener should be attached.	1 pack	
2.2.	Pencil pack	Pack of 10 pencils. Black lead core (3mm core), grade HB, quality wood casing, painted, hexagonal in shape, suitable for use on paper and plastic slate surfaces. C. Schedule of Requirements:

Award: UNFPA has the right to place an order for all or some of the items. UNFPA will select only one supplier for each item based on the price and technical comparison.

Partial bid: Bidders are allowed to submit a partial bid. Which means a bidder can submit its offer for more than 1 item or all items. However, the sub-items such as shampoo, soap etc included in the set items or kits should not be separated from the items. It should be considered as a single item.

Delivery time: The goods are to be delivered maximum in **Ten (10) days** upon approval of the order.

Liquidated damages: In the event of a Contract being issued and in case the Vendor fails to deliver all the goods by the date or dates of delivery specified in the Purchase Order, UNFPA reserves the rights to claim liquidated damages from the Vendor and deduct 1% of the value of the goods pursuant to the Purchase Order per additional week of delay, up to a maximum of 10% of the value of the Purchase Order. The payment or deduction of such liquidated damages shall

not relieve the Vendor from any of its other obligations or liabilities pursuant to any current Purchase Order.

Customs clearance: Shall be done by the Awarded supplier if customs clearance is needed.

Packaging and labelling:

- For item 1, all sub items should be packed in backpacks to be provided by UNFPA. If requested by UNFPA, the selected supplier will be asked to put the items 2, 3 and 4 supplied by other suppliers to the dignity kit backpack or carton boxes.
- Every kit (with backpacks) should be packed in a 5 layered white colored durable carton boxes. UNFPA's logo and the words “Эрүүл ахуй, ариун цэврийн багц” in blue color should be imprinted on two sides of the carton boxes as below instead of the words **Dignity kit**.



The list of the items included in the carton boxes should be whether imprinted, glued or stuck on the empty side of the carton boxes.

The selected supplier will be requested to prepare 1 box with logos and marks, take a photo and send it to the UNFPA for approval.

Liquid items shall be adequately sealed in a way to avoid any leakage during transportation or storage. Bidders shall identify their method of proper sealing.

The goods are to be delivered maximum in **10 days** upon issuing of PO. The quotation shall be valid at least for **2 months** after the closing date.
