1. Description of Requirements

The World Health Organization (WHO) invites vendors to submit an Expression of Interest (EOI) for **supply and installation of block-modular solid fuel water heating boiler house at Ukrainian hospitals.**

WHO CO Ukraine intends to purchase the equipment of a block-modular solid fuel water heating boiler house to provide alternative heating of hospitals premises, its installation and commissioning to ensure the high-quality and uninterrupted operation of the medical facilities in the absence of centralized heat supply and also to reduce the financial costs of the hospitals, which would make it possible to make medical services more accessible.

WHO CO Ukraine is looking for reliable vendors to express their interest in future tender opportunities under the subject.

Normally, the bidders would be required to offer the supply and installation of a boiler house which would have to be equipped with:

- solid fuel water heating boilers with different capacity (ranging from 250 to 500 kW each with automatic manual loading of fuel (firewood, pellets);
- set of thermomechanical equipment with network pumps, shut-off valve armature;
- system of valves and filters;
- safety and regulation automation system;
- electricity consumption accounting system;
- power supply and lighting system;
- fire alarm and fire extinguishing systems
- gas alarm and emergency lighting.
- heating and ventilation system.

The bidders would have to ensure the preparation of the technical design (and its approval with local authorities), as well as provision of all construction works related to the installation of the boiler house.

The hospitals are located at different regions of Ukraine, at the territory under control of Ukrainian government.

Detailed scope of supply and services would be shared with the interested bidders at the time of each tender announcement, the set of bidding documents would contain technical specification requirements, hospital location information, etc. For now, this is a sourcing exercise to find prospect and technically compliant suppliers. Interested companies are required to fill out the questionnaire in [Annex A](#) below, providing all the requested information and documentation.

2. Minimum Criteria for Vendors

Companies can only participate in this Request for EOI from WHO after completing their basic registration (free of charge) at the United Nations Global Marketplace (www.ungm.org).

- Suppliers shall be operating in the field of supply and installation of heating equipment and/or construction, reconstruction or repairing projects.
- Suppliers shall have all licenses and permits issued by the respective authorities of Ukraine in order to operate and provide corresponding services in Ukraine.
- Suppliers shall have minimum 2 (two) completed contracts of similar nature and complexity implemented over the past 5 years.
- Previous work with WHO, other international organizations in the field of similar supplies/services is an asset.

3. Expression of Interest Instructions

Vendors interested in fulfilling the requirements are requested to express their interest by submitting the following documents, completed in full, to the Contact Address (as stated above) not later than the Closing Date (as stated above):

1. The completed **Expression of Interest Form**, using the template provided in [Annex A](#), providing all the requested information and documentation. Separate files can be submitted in the response, where necessary.
2. A **Vendor Information Form**, using the template provided in [Annex B](#), providing information on the vendor as an entity (legal and organizational), and describing concisely and briefly the vendor's expertise and experience relevant to the requirements and criteria described above.
3. A **self-declaration form**, using the form provided in [Annex C](#).

Submitted Expressions of Interest should not contain pricing information.

Any information considered by interested entities as confidential must be clearly marked "confidential".

Incomplete Expressions of Interest and Expressions of Interest submitted after the Closing Date will, in principle, be disregarded, unless WHO decides otherwise, in its sole discretion.

4. Disclaimer

This Request for Expression of Interest is not a solicitation and replying to it does not guarantee that a vendor will be invited to any solicitation by WHO. No further details of the planned solicitation will be made available to vendors prior to the issuance of solicitation documents. In the event of a solicitation for the subject matter described herein, any Request for Proposal and any subsequent purchase order or contract will be issued in accordance with WHO's rules and procedures.

Any and all costs and expenses incurred in relation to, or ensuing from, the submission of an Expression of Interest will exclusively be borne by the applicant. The application and selection process set forth in this document will not be subject to claims for financial compensation of any kind whatsoever.
