Technical specifications

Annex A

1. Material Compliance (Pass/Fail)

- **Required:** Soft cotton or cotton blend that is breathable and hypoallergenic.
- **Test:** Require fabric composition details and proof of certification (e.g., Oeko-Tex Standard 100 or similar).
- **Pass/Fail Criteria:** Supplier fails if material does not match the specification or lacks certification.

2. Product Design and Style (Pass/Fail)

- **Required:**
 - **Men:** Boxers
 - **Women:** Bikini styles
 - **Children:** Simple bikini styles
 - **All Ages:** Sleeveless underwear
 - **Underwear Cotton Outfit:** Long cotton pants and long-sleeved shirt
 - **Socks:** Half-calf style
- **Test:** Supplier must submit a design sheet or sample for each type.
- **Pass/Fail Criteria:** Supplier fails if they cannot provide designs in all required categories (e.g., missing children's or women's underwear).

3. Size Range and Quantities (Pass/Fail)

- **Required Sizes:** Small (S), Medium (M), Large (L), Extra Large (XL).
- **Age Groups and Quantities:**
 - Separate sizes for children, teenagers, and adults based on your detailed table.
- **Test:** Supplier must provide a clear breakdown of available sizes and quantities matching your specification.
- **Pass/Fail Criteria:** Supplier fails if any size or age group is missing from the proposal.

4. Color Options (Pass/Fail)

- **Required:** Black, white, grey, and pastel colors.
- **Test:** Supplier must indicate the color options available.
- **Pass/Fail Criteria:** Supplier fails if they do not offer all specified color options.

5. Infant Cotton Outfits (Pass/Fail)

- **Required:** 200 infant cotton outfits, color preference white or off-white.
- **Test:** Supplier must confirm availability of 200 units in the specified colors.
- **Pass/Fail Criteria:** Supplier fails if they cannot meet the infant outfit requirement.

6. Packaging and Labeling (Pass/Fail)

- **Required:** Packaging should clearly label sizes, quantities, and age group.
- **Test:** Supplier must provide packaging details and labels.
- **Pass/Fail Criteria:** Supplier fails if labeling or packaging is unclear or doesn't meet standards (e.g., missing size or age group information).

7. Delivery Time and Location (Pass/Fail)

- **Required:** Delivery to UNHCR's partner SARC, Masar warehouse in Damascus.
- **Test:** Supplier must provide a confirmed delivery schedule.
- **Pass/Fail Criteria:** Supplier fails if delivery time is not acceptable or immediately, or if they cannot deliver to the specified location.
