1. Object of the Consultancy

1.1. GENERAL OBJECTIVE

To provide technical assistance to design and implement an educational intervention that presents evidence of the results of rural school students' learning achievement in mathematics and/or reading, in 50-60 Spanish monolingual rural elementary public schools.

1.2. SPECIFIC OBJECTIVES

- To prepare a technical proposal for the design and implementation of an educational intervention, with evidence, aimed at improving the learning achievements of students in rural multigrade elementary schools, monolingual in Spanish, in reading and mathematics. The proposal should include milestones, responsibilities and timelines for all lines of work.
- To develop a proposal for data collection instruments to monitor students' learning progress and the implementation progress of the intervention.
- To provide technical assistance to DIF during the process of designing and implementing the proposed educational intervention.
- To provide technical assistance in the process of developing materials to support teachers in rural multigrade schools to strengthen their students' basic math and reading skills.

The purpose of this notice is to provide general information on the requirements for the procurement process and to inform interested suppliers how to obtain a copy of the Solicitation Documents.
