The United Nations Educational, Science and Cultural Organization (UNESCO) hereby invites qualified companies to submit proposals to conduct an **Evaluation of UNESCO's Action to Prevent Violent Extremism (PVE)**.

The evaluation will be conducted between April and October 2019 and is estimated to require approximately 75 professional working days.

The main deliverables will be an inception report, a draft and final report, and summary communication outputs.

The evaluation team will be composed of one senior evaluator (team leader) and one thematic expert. The evaluation team leader should possess the following profile:

- Advanced university degree in social sciences, political sciences, economics, or related field; specialized training in planning, monitoring and/or evaluation of social programme or policies will be an asset;
- At least 10 years of working experience in evaluation acquired at the international level or in an international setting;
- At least 5 experiences in evaluation leading an evaluation team;
- Knowledge of data collection and analysis methods (quantitative and qualitative).
- Excellent analytical and demonstrated excellent drafting skills in English;
- Knowledge and understanding of the development needs in the field of PVE or similar areas such as peace education and or youth and peace;
- Work experience in the UN or experience with assignments for the UN;
- Understanding and application of UN mandates in Human Rights and Gender Equality.

The purpose of this notice is to provide general information on the requirements for the procurement process and to inform interested suppliers how to obtain a copy of the Solicitation Documents.

Interested companies who wish to participate in the OIC must request for a complete set of Solicitation Documents, available free of charge, from UNESCO contact person at the address shown below.

The tenders must be submitted electronically to the UNESCO email address indicated in the solicitation documents on or before **20 March 2019 at 23:59 hours (CET)**, in strict compliance with the instructions as stipulated in the solicitation documents.
