DESCRIPTION OF REQUIREMENTS

MONUSCO seeks Expression of Interest (EOI) from reputable companies/services providers for the Provision of Cross Border Insurance cover (COMESA) for MONUSCO Fleet Vehicles in Democratic Republic of Congo for following services :

1. Policy and cover :The policy shall provide the designate MONUSCO vehicles with insurance coverage when travelling in to countries bordering the Mission area. The policy will cover the insured vehicle for third party property damage or loss, vehicle accident damage and personal injury;
2. Transfer of policy :When activated, the policy will cover the vehicle mentioned on the COMESA Yellow Card. The Mission requires that the policy be transferable to a similar vehicle given the nature of the work of the Mission. In all cases a similar make, model age and engine sized vehicle will be proposed for transfer.
3. Designation of vehicles :Given the diverse range tasks needing to be accomplished and other extraneous circumstances, the Mission requires the following:
 - The vendor should be willing to provide cross border insurance cover for 4x4 jeep type, busses 8 to 55 passengers, light medium and heavy trucks, truck tractor unit with trailer.
 - The vendor should be willing to provide cover for wheeled machinery and any other motorized equipment.
 - The vendor should be willing to provide cover for military pattern vehicles engaged in the support of the Mission mandate

La MONUSCO lance une Expression d'Intérêt (EOI) auprès de sociétés / fournisseurs de services réputés pour la fourniture d'une couverture d'assurance transfrontalière (COMESA) pour les véhicules de la flotte MONUSCO en République démocratique du Congo en rapport avec les services suivants:

1. Police et couverture: La police doit fournir aux véhicules MONUSCO désignés pour une couverture d'assurance lorsqu'ils se rendent dans des pays limitrophes de la zone de la mission. La police couvrira le véhicule assuré pour le dommage ou la perte de biens de tiers, les dommages causés par accident du véhicule et les blessures corporelles;
2. Transfert de la Police: Lorsqu'elle est activée, la police couvrira le véhicule mentionné sur la carte jaune COMESA. La mission exige que la Police soit transférable à un véhicule similaire compte tenu de la nature du travail de la mission. Dans tous les cas, une marque similaire, un modèle d'âge et un véhicule de taille de moteur seront proposés pour le transfert.
3. Désignation des véhicules: compte tenu des diverses tâches de la gamme à accomplir et d'autres circonstances étrangères, la mission requiert ce qui suit:
 - Le fournisseur devrait être disposé à fournir une couverture d'assurance transfrontalière pour le type jeep 4x4, les bus 8 à 55 passagers, camions légers et lourds, tracteur camion avec remorque.
 - Le fournisseur devrait être prêt à fournir une couverture pour les machines à roues et tout autre Équipement moteur .
 - Le fournisseur devrait être disposé à couvrir les véhicules de modèle militaire engagés dans le soutien du mandat de la mission

1) Registering as a Vendor with the United Nations
